

BeFibre MONY Group eGift Card Promotion – Terms and Conditions

1. Campaign Overview

The eGift Card promotion (the "Offer") entitles eligible customers who purchase via MONY Group to receive:

- A £50 Gift Card with the Be500 24-month package.

This Offer is available exclusively to new customers who sign up for one of the above packages via MONY Group between **25th February 2026 and 31st March 2026** inclusive.

2. Eligibility

- Runa E-Gift card will be delivered around 45 – 50 days from the second bill payment and will appear in your email inbox as sent from noreply@mail.runa.io – please check your junk mail before chasing a late Runa Gift Card.
- No codes are required to redeem this Offer. Customers must sign up through MONY Group.

5. Gift Card Details

- The eGift Card will be delivered digitally to the email address registered to the broadband account.
- Gift cards are issued subject to Runa's own terms and conditions.
- There is no cash alternative, and the gift card is non-transferable and non-exchangeable.

6. Conditions of Use

- If the broadband service is cancelled within the minimum contract period, BeFibre reserves the right to reclaim the value of the gift card through a final bill adjustment.
- The Offer cannot be used in conjunction with any other BeFibre promotional offers unless explicitly stated.
